Applicants applying for the Cosmetology program will need to have the following items on file in the Office of Career & Technical Education.

- 1. Completed SMCC Cosmetology Application.
- 2. A copy of high school diploma transcript or GED transcript.
- 3. ACT score of 14 or higher or equivalent placement test score.

Current high school seniors may complete the Cosmetology application with an inprogress transcript.

Applicants applying for the Cosmetology program will be required to complete an interview. All applicants in good standing with the Southwest Mississippi Community College Admissions Department and with completed application packets will be granted an interview.
